Course and Program Outcomes - J. Chevalier	<ul> <li>The Outcomes Plan was approved last semester and includes policy recommendations in the Executive Summary. At this point the Outcomes Committee doesn't know how the plan will be implemented</li> <li>4. Should say 3-5 year cycle. Currently there is no mechanism for ensuring that courses are assessed during this time frame. There was some discussion of including assessment information on the cover sheet for courses during the 4-year review. Should outcomes be in the COR for deans to see if outcomes have been assessed?</li> <li>Jason suggested using stage 4 to double check if SLO's have been done.</li> <li>Eric indicated that the Outcomes Committee would need additional support to review courses for outcomes data at stage 4. Donna suggested attaching a screen shot from trackDat. Terri explained that it is possible to add SLO as stage 4, but she would need to consult with the deans about the additional workload. Eric did not anticipate that SLO assessment would affect curriculum review. Chairs would also have to be consulted. Eric asked if this can turned into something closer to EDC in which someone could process and spot check for compliance. Terri suggested that WebCMS may be able to provide a mechanism to extract courses that have SLO data included on the cover sheet. If this was possible, it would certainly assist the Outcomes Committee. New courses and programs should not go through EDC without SLOs or program level outcomes.</li> <li>Confirming that outcomes are established is much easier than determining whether or not outcomes have been assessed.
