Other Issues	<ol> <li>The Committee reviewed Biological Sciences (Anthropology and Biological Sciences) requests. Michelle Grimes-Hillman described a recent concern from the Instruction Office regarding any equivalency option where a degree (other than a BA) is not completed. The concern is that we could potentially hire a tenure-track faculty member who never completes the doctorate degree and therefore is teaching credit courses in an academic department with only a bachelor's degree.</li> <li>The Committee reviewed Foreign language department requests. Each discipline (Japanese, Spanish, Italian, Chinese) was examined individually.</li> <li>Michelle will contact the department to request that a time limit is added to the Biological Sciences requests.
