Review Group Memory - September 8, 2009	Group Memory was revised to include the following items: #7 – It was the consensus of the Committee to support the Kaiser “Walk Across America.” #8 – A COBRA notice was sent to all benefit-eligible employees notifying employees of their right under the federal law. 4. Delta Dental Plan – Liz Garcia, ASCIP, and Joni Jones, Delta Dental	Liz Garcia explained the history behind ASCIP’s decision to consolidate its dental offerings into three plans. ASCIP inherited 57 custom plans from LARISA, and ASCIP has streamlined these 57 plans into three options -- Plan A, B and C. Plan A is the best of the three PPO plans offered, and it was selected as Mt SAC’s plan. Plan A did not reduce the level of benefits currently offered to employees. The Enhanced PPO Plan A will have improved diagnostic, basic and prosthodontics benefits and will take effect on January 1, 2010.
