**Committee Members:** 

1. Minutes from September 12, 2013 were approved with minor revisions.

2. Student Success and Support Implementation Summit: The Summit was focused on SB 1456. Most of the presentations were informational. Presentations included how California Community Colleges are adapting to and meeting mandates of SB 1456. De Anza is offering 81 sections of a half unit counseling class during the summer where orientation takes place. We have already modified our orientation to be more interactive. We are continuing to look at ways to improve student success. Audrey Yamagata-Noji, George Bradshaw, Jim Ocampo, and Tom Mauch presented at the Summit.

The allocation of funds was announced. It looks like we will get 1.2 million which is what we expected. This almost gets us back to where we were before the budget cuts. However, the numbers of enrollments looked incorrect.

- 3. High School Faculty/Counselor Conference: The High school Faculty/Counselor Conference is going to be November 8, 2012. Mt. SAC Faculty are invited to attend, but at this point faculty will not be presenting as they did last year. T.Mauch will clarify whether or not faculty are invited to present and notify Matriculation representatives as soon as possible.
- 4. AWE Rubric: 12 readers attended a preliminary training session. A few changes were made to the Rubric. Facilitators met to select sample papers. Training will take place this

Friday, September 27 for 3 hours. The first readings with the new Rubric will take place

on October 11, 2013.

Our October 9<sup>th</sup> meeting will be spent working on the AWE Pilot. M. Sampat will invite Beta

Meyer, Pam Arterburn, Sun Ezzell, and Barbara McNiece-Stallard to attend as specified in the

AWE Senate Resolution.

5. IELTS

M. Dougherty will share feedback from the English department at the next meeting.

AMLA shared that IELTS is not a placement test. It is a proficiency test. It's not an appropriate test for use as a placement. It has not been approved and it is unlikely that the IELTS would be

approved for use as a placement instrument.

Additional questions were shared. Faculty want to know which department the IELTS would be

housed in and where the funding would go.

6. Math Update: D. Beydler inquired whether the satisfaction surveys had been delivered.

He shared the concept of developing math assessment prep workshops with the math

department. A math faculty member noted that assessments are given at high schools.

High school Outreach does go to high schools with a PowerPoint presentation, so it is still possible to reach those students. D. Beydler contacted the MARC and TMARC staff who

may be able to offer workshops on Fridays. M. Sampat and D. Necke shared that Learning

Assistance and Noncredit offer math workshops. It would be advisable for representatives from

Math, Learning Assistance, and Noncredit to meet and develop a workshop.
