4. SSSP Plan	<ul> <li>4.1 SSSP Plan discussion and revisions:</li> <li>Page 10: WIN Boot Camps need to be changed to Adult Basic Ed Boot Camp.</li> <li>On page 13 D. Beydler asked that clarification of "automated" Multiple Measures be added to reflect that MMs are currently input manually by assessment staff.</li> <li>Since Multiple Measures have been available online, 8,521 students have taken surveys before testing.</li> <li>Eric Kaljumagi and D. Beydler will teach two Math Info. Sessions per week this semester. J. Ocampo mentioned that additional faculty can be hired for Math Info. Sessions at the hourly rate. Also, more sessions can be scheduled because there is funding. Summer was the best attendance so far with 207 students attending Math Info. Sessions. J. Ocampo reported that David Charbonneau (Writing Center) thanked the assessment staff for advertising the English Test Prep. Workshops.</li> <li>There was a question about the number of students served by assessment from July 1, 2014-June 30, 2015. J. Ocampo stated that the latest data on assessment looks better (77% vs 56%). Current percentage includes unduplicated students who completed orientation, assessment, and Ed. Plan anytime before, during, or after the reporting period and registered for a class. M. Tsai mentioned that some students are still able to register for certificate programs without assessment. This data should align with MIS (Management Information System) reporting which is now tied to funding.</li> </ul>	<ul> <li>4.1 Group members will send color coded revisions with page numbers to L. DeLeon (cc J. Ocampo) no later than Monday, 9/14/15 before noon.</li> <li>L. DeLeon will send revised SSSP document to SP&amp;S in time for 9/21/15</li> </ul>

5. Third Prompt Data	5.1 Third prompt data from 5/11/15 to 8/25/15 was shared by E. Hill-Enriquez. During this time period, 413 (8.4%) out of 4,938 students chose to respond to a new third prompt which is tied to a quote. Facilitators and assessment staff collected data on students who chose third prompts and tests were scanned. E. Hill-Enriquez explained that for students who chose the third prompt, 24% were placed into ENGL 1A while 14% who chose to write on the first or second prompt were placed into ENGL 1A. Placements in ENGL 67 and LERN 81 shifted up by 4% and 2% respectively for students who chose the third prompt. RIE will be examining success rates ("C" or better grade) in placements for these 413 students.	
6. Common Assessment	6.1 D. Beydler will attend the next Common Assessment Meeting on 9/25/15. Several SSSPAC members	
	attended the Flex Day Common Assessment Workshop. J. Ocampo noted that campus by campus placements will be different because Multiple Measures and cut scores will be set locally. Common Assessment essays will be scored via computers; however, colleges will have the option to score essays with their own readers. At this time, it is unknown if the Chancellor's Office would fund local readers. J. Ocampo would defer a decision on Mt. SAC's use of computer vs reader essay scoring to English, AmLa, and Learning Assistance. Common Assessment is scheduled to begin in Fall 2016. Pilot schools are scheduled to begin Common Assessment in late winter.	
7. Updates	7.1 AWE: AWE samples have been updated on the website. There will be an AWE reader training on	

October 9th for seven new readers. During fall, AWE readings will take place on Wednesdays (1:30-4:30pm) and Fridays (9:00am-12:00pm). J. Ocampo reported that through the years, the cost of AWE readers has increased, but the AWE budget has not. Each year, additional funding is requested. This year, SSSP funds have been allocated to augment the AWE reader budget.

- 7.3 Counseling: A. Lujan recommended mandating
  Orientation before assessment testing and inviting
  math, English, and Learning Assistance to be part of
  orientation. A. Lujan also would like to see students
  attend test prep. info. sessions before testing
- 7.4 Continuing Ed./ESL: D. Santiago reported the following:
  - Madelyn Arballo is the new Dean of Continuing Education
  - o 3,400 students were tested last year.
  - o Three part-time counselors have been hired
  - Currently non-credit version of SSSP is being drafted
  - D. Santiago will attend Region 8 SSSP Meeting at Rio Hondo this Friday. J. Ocampo will also attend. A recommendation was made for L.
     DeLeon to also attend.
  - D. Necke reported that over the summer, Boot Camp served 200 unduplicated students
