- President's Awards evaluation
 - Discussed placement of Bridge Program as a recipient for the Outstanding Basic Skills Efforts category. The finalists include Outstanding Curriculum Efforts (Speech), Outstanding Basic Skills Efforts (Bridge Program), and Personal Innovation (Martin Mason).
- Stage 4 recommendation AP 4020 Recommendation
 - To ensure that course and programs are assessed regularly, the Outcomes Coordinator will review all courses at Stage 5 in WebCMS between June 1-15 and forward a list of courses that have not been assessed in the last 4 years to the Curriculum Liaison, Dean of Instruction, and the Department Chairs of the assigned courses.
