Old Business

- TracDat 5 Planning for Transition
 - Revision to TracDat is ongoing with support from Kate Morales, Coordinator, Computer Services, Information Technology.
- Student Campaign for Outcomes Awareness
 - A meeting was held on November 20 to discuss the possibility of creating a short video to inform students about the assessment of student learning outcomes. The meeting included Annel, Emily, Edwin Romero, Student Activities Coordinator, and two students, Jonnatthan Ortez and Matt Retana. The students requested support to produce the video in order to ensure good quality and turnaround time.
- Outcomes Terminology
 - Outcomes Committee members have been discussing the use of course measurable objectives (CMOs) and student learning outcomes (SLOs) for course assessment. Members question whether using both CMOs and SLOs is helpful or confusing to faculty and students.
 - The committee invited Mary Ann Gomez-Angel and Richard Strand to speak at this meeting because their departments won the 2014-15 Presidential Awards for Excellence and Innovation in Teaching and Learning. Both professors shared

their experiences with outcomes assessment. In addition to the discussion of CMOs and SLOs, discussion also included:

- Setting meaningful criteria for success
- Obtaining assessment data and use of results
