	YOU MUST SUBMIT THE CADAA IF:
	1. Attended a California high school for at least three years, or
	<ol> <li>Attainment of credits in California from a California high school equivalent of at least three or more years of full-time high school coursework and a total of three or more years of attendance in California elementary schools, California secondary schools, California adult school or a combination of those schools, or</li> </ol>
	3. Credits earned at a California Community College, <b>or</b>
	4. A combination of the school listed above
	<ol> <li>Graduated or will graduate from a California high school or attainment of General Education Development (GED), High School Equivalency Test (HiSET), or Test Assessing Secondary Completion (TASC), CA High School Proficiency Exam (CHSPE), or</li> </ol>
	6. Attainment of an associate degree from a California Community College, or
	<ol> <li>Fulfillment of minimum transfer requirement from a California Community College to a University of California or California State University, and</li> </ol>
	8. Will register or enroll in an accredited and qualifying California college or university, and
1	<ol> <li>If applicable, complete an affidavit to legalize immigration status as soon as you are eligible, and</li> <li>Do not hold a valid non-immigrant visa (F, J, H, L, A, B, C, D, E, etc.)*</li> </ol>
1	* If you have Temporary Protected Status or hold a U visa select "Yes"
2	<ul> <li>GATHER YOUR DOCUMENTS – Gather this information before you go to DREAM.CSAC.CA.GOV to complete your CADAA:</li> <li>Social Security Card or Individual Taxpayer Identification Number (if you have either one of them)</li> <li>Driver's license (if you have one)</li> <li>Federal income tax returns, W-2s and other records of money earned for the specified year</li> <li>For the 2023-2024 CADAA you will be using 2021 tax and income information.</li> <li>Current bank account balances and records of investments and untaxed income</li> <li>If you're a dependent student, you'll also need your parent(s)' information.</li> </ul>
	FILL IT OUT – After you start your application at DREAM.CSAC.CA.GOV, you will complete the sections below:
	Student Demographics – When entering your personal information, read directions carefully and enter information accurately.
	<ul> <li>Double-check your name, date of birth. Even one small error could cause delays.</li> <li>School Selection – Select the college, university or career technology center you plan to attend. You can select up to 10 schools.</li> </ul>
	You will also need to indicate whether you plan to live on campus, off campus or with a parent.
	<b>Dependency Status</b> – A list of questions will determine whether you are considered dependent or independent on the CADAA. Dependent students will be required to provide parental information.
2	Parent Demographics – Dependent students must enter information about their legal parent(s).
5	<ul> <li>If your parents are legally separated or divorced, list the parent you lived with the most during the last 12 months.</li> </ul>
	<ul> <li>If your parents are legally separated or divorced and you lived with them equally, list the parent who provided the most financial support in the last 12 months.</li> </ul>
	<ul> <li>If your divorced parent is remarried, list both your parent and step-parent.</li> </ul>
	<ul> <li>If your parents are unmarried but living together, list information for both parents.</li> </ul>
	<ul> <li>If your parent is undocumented, use 000-00-0000 as his/her Social Security Number.</li> </ul>
	<b>Financial Information</b> – You can enter the specified income tax information.
	SIGN AND SUBMIT – Review your answers. If you are considered dependent, your legal parent is also required to sign your CADAA

by creating a PIN.
