Fall 2021 AQ Survey planning subgroup: Met June 2 and finished review/revisions to AQ survey questions.</li> <li>4. <p>3. <a href="#">Chemistry Placement</a> (David)</p>	<p>Per Todd Clements, the Chemistry Department approved the following:</p> <ul style="list-style-type: none"> <li>• Counselors/admissions approving clearances for entry into CHEM 50 based on the department’s published guidelines whether from AP scorers or high school work</li> <li>• Students will receive credit for CHEM 40 from AP scores as such credit does not impact registration priority</li> <li>• The following criteria will be used for multiple measures placement: “B” or better in MATH 71 or an algebra type course or higher math course) in high school; and 12 units at Mt. SAC with a 3.0 GPA or higher or a high school GPA of 3.2 or higher. Meeting these criteria will also allow entry into CHEM 50.</li> </ul> <p>Admissions &amp; Records uses the catalog as a guide to input credit for AP scores, so the minimum AP score for CHEM 40 credit should be listed in the catalog.</p>	<p>D. Beydler will contact Todd Clements to clarify “published guidelines.”</p>

5. Fall 2021 AQ Survey ( <a href="#">Faculty</a> , <a href="#">Student</a> ) (David)	<p>Subgroup met and made revisions. For AQ faculty survey, student names should be in alphabetical order by last name. For student survey, the questions about reasons for taking class will have an additional “other” text box. When asking students about level of difficulty, the branching option for those who believe the course is too difficult will see options related to preparation, course content, and online modality.</p> <p>Student messaging and instructions to faculty who administer the survey will be drafted in fall.</p> <p>In the fall, data will be collected to explore students’ confidence levels in passing their classes with their course success rates.</p>	Revisions to the AQ Student and Faculty Surveys were unanimously approved.
6. <a href="#">2021-22 Meetings</a> – Online or In-Person? (David, George)	It was agreed that meetings will take place online in fall. Also, a person to take minutes is needed for next year.
