It was agreed that one of the faculty positions should always be filled by a counselor from the Counseling department. Meghan will be completing Sarah Daum's 2005-08 term and offered to remain on the committee in the administrator position for the next three-year term. Mary Johnson has expressed interest to Academic Senate in continuing as Assistant OLFM for 2008-09. Suggestions to the membership included replacing Dale Vickers with Shanti Atashpoush for the IT administrator position and changing it to an ongoing position. Blackboard Update	Kerry is continuing to work with Blackboard and reported they are closer to a solution to the Snapshot problem.
