K. Allende asked if the Chancellor's office has given guidance on this topic. P. Wolf would courses like surveying courses or robotics be considered activity courses as well? K. Allende shared that those are listed as Labs and therefore aren't classified as activity. N Tharp added that this is important in his department to extend to what courses labeled as labs. K. Allende shared details from the Chancellor's executive order about suspended portion of Title V, referring to section 55045B. Wherein any course that was in progress on March 4<sup>th</sup> for which the presentation of the educational material was changed in mode, students may use that as an extenuating circumstance to repeat a course. C. Uyeki believes this may mean the resolution is moot. K. Rivera recommended move to table to 4.30.20 while we verify that the resolution is moot given the Chancellor's executive order.
