High Level Pool Comparison

CalPERS

- CalPERS offers 6 carrier options:
 - Anthem, Blue Shield, Kaiser, HealthNet, Sharp, and UHC
- 10 HMO and PPO options
- Carriers utilize 3 PBM:s
 - CVS/Caremark, Optum Rx
 - Kaiser

SISC

- SISC offers 3 carrier options:
 - Anthem Blue Cross <u>OR</u> Blue Shield, and Kaiser
- 40 + HMO and PPO options
- Carriers utilize 2 PBMs:
 - Navitus Rx
 - Kaiser


*PBM is a Pharmacy Benefit Managers, which is the entity that manages pharmacy benefits.





Infertility Benefit Carrier Comparison

- Anthem Blue Cross and Blue Shield
 - HMO options cover diagnostic and testing for **infertility** at 50% and is not subject to the copay limitations.
 - Does not cover any fertility treatments including but not limited to, IVF or surrogate mother services
 - Neither Anthem Blue Cross nor Blue Shield PPOs have infertility/fertility coverage.
- Kaiser
 - Covers diagnostic and testing for **infertility** at 50% and is not subject to the copay limitations. This benefit is subject to specific limitations.
 - Does not cover any fertility treatments including but not limited to, IVF or surrogate mother services

WARNING: See Evidence of Coverage for detailed list of covered services.

Infertility means: (1) you have a health problem your doctor sees as the reason you are unable to have a baby; or (2) you are unable to get pregnant or to carry a pregnancy to a live birth after a year or more of having sex without birth control or after 3 cycles of artificial insemination.

"Fertility Services" means treatments and procedures to help you become pregnant.
