




# Child Development Permit Stipend Funding Program

## Child Development Permit Stipend Program

Submit eligible Child Development Permit applications through CDTC for funding and apply for fingerprint processing fee reimbursement.

Select and print appropriate permit application forms with instructions.

## Child Development Permit Stipends

The Child Development Training Consortium (CDTC) accepts Child Development Permit applications prior to submission to the California Commission on Teacher Credentialing (CTC). The CDTC reviews applications for completeness and issues payment of the permit application fee on your behalf, when applicable. The CDTC submits eligible Child Development Permit applications, with the application fee, to the CTC for final review, approval, and issuance.

**Only current Program Year application forms are accepted.** To get started, select and print the instructions and application forms from the CDTC website, based on the type of experience you are using to apply for a permit (Center Based or Family Child Care Owner). For processing purposes, **only print forms on one side of the paper.** Double-sided forms will be returned unfunded.

### Child Development Permit Funds Project

The Child Development Permit Funds Project is available to applicants statewide. The CDTC pays the permit application fee (if eligible) and Live Scan fingerprint processing fee reimbursement (if applicable) for the Child Development Permit levels listed below, including permits with a School-Age Emphasis.

- 1. First Time Permits:** Assistant, Associate Teacher, and Teacher
- 2. Permit Renewals:** Assistant, Associate Teacher, and Teacher (Valid and expired permits are eligible to submit for renewal)
- 3. Permit Upgrade to any Higher Level Permit from these Permit Levels:** Assistant, Associate Teacher, and Teacher (Valid and expired permits are eligible to submit for upgrade)
- 4. Teacher Permit Online Renewal:** CDTC can reimburse the \$100 online renewal fee for the Teacher Permit level only.

**Stipend applicants may only receive one permit stipend each program year.** Funding is limited based on availability. Permit extensions or downgrade fee payments and reimbursement of permit applications sent directly to the CTC are not eligible. **CDTC will only allow applicants to resubmit an incomplete or incorrect permit application one time each program year. Refer to Submittal Checklist prior to submission.**
