1. Review of Minutes	The March 2013 minutes were approved.	The minutes are posted online and in the ITAC Group Studio.
2. PAC Update	Vic reported that there is no PAC update. The next meeting he is scheduled to attend is April 9.	Information Only
3. Pending IT Projects	<p>The committee discussed the status of several pending IT projects. IT is working with the Document Imaging committee to review proposals from two vendors for new document management systems. They hope to recommend a system to President's Cabinet by June. Jim Smith asked about the implementation time line for an imaging system. Vic indicated that Phase I implementation would be to convert the documents in the existing Hershey system to the new system and provide the functionality that exists in Hershey. Phase II would involve working with individual departments to implement new features for managing documents and workflow. Vic would like to see phase I start in Fall 2014.</p> <p>Vic discussed the conversion of student email to Gmail project. IT anticipates making the transition during May 2014. The students will retain their same email address and old mail will be converted to Gmail. IT and Marketing have started a information campaign for students. 5. DL Report	Paul discussed the mock accreditation review of distance learning courses which is ending on April 22. He also discussed the need for departments to be aware of programs that are 100% online. These programs must be approved, prior to being offered, by the State.
