3.0	Basic Skills Committee funding - 2013-14	The Basic Skills Committee sent a call for proposals in December 2012, with a due date of April 1, 2013. Glenda and conducted orientation sessions. The Committee members ranked the proposals based on the established rubric. Out of 25 submissions, 4 were recommended not to be funded. The requests (\$1,052,431) exceeded the estimated funding amount (\$841,276). After SP&S, the recommendations will be forward to the Senate Executive Board. Glenda clarified the major qualifying issue for not funding recommendations is the ability to not fully measure the direct outcome from basic skills funded interventions. BP 5010 – Admissions -	The Council discussed and reviewed the following two proposed revisions of 5010: 1) An originally drafted version by George based on the original version brought forward by President Scroggins. 2) Eric then worked on revising the version George drafted. Discussion: The Ed Code provides that students can be admitted provisionally. George recommended including the admission of other students (concurrent enrollment) to be comprehensive. George recommends a reference to provisionally admitted students per Education Code. Suggestion is to add a 4th bullet (Eric's version) to read: Other persons who, in the judgment of the College President/CEO or his/her designee are capable of profiting from the instruction offered. Move "Admission to Specialized Programs" to the end of the BP after "Special Admission of Highly Gifted Students."
