Shailah, during her campaign, has asked for the endorsements of multiple RSCOs (recognized student clubs and organizations). In one known case, Shailah asked the "Philosophy Club" for an endorsement. The club responded by saying they would not be endorsing any candidate, but they would announce the AS elections. Shailah then contacted Elena Pogosova, the ex-president of the Philosophy Club (no longer a student of Mount SAC) for an endorsement. Elena then posted an endorsement onto the Philosophy Club Facebook page, to which Valeria (the current Philosophy Club president) and no other current club members, officers, or advisors have access to. Valeria then messaged Shaliah, letting Shaliah know that the Philosophy Club does not endorse Shailah and to remove the post. Shailah, after multiple requests, did not comply until Valeria emailed Giovanni Rodriguez, AS Advisor, and informed him of the facts. Giovanni Rodriguez found that Shailah should remove the endorsement. Shailah has not apologized or released a statement pertaining to the removal of the post. (Please see correspondence between current Philosophy Club President and Shailah attached as the second exhibit; please see social media posting of Philosophy

1 Club endorsement attached as the third exhibit.) 2 V. THIRD CAUSE OF ACTION 3 PERSISTENT MISCONDUCT 4 5 Mount SAC Standards of Conduct; Section 18. "Persistent, serious misconduct where other means of correction have failed to bring 6 about proper conduct." 7 A.S. Constitution Article 3, Section 4: "No elected or appointed 8 officer of this Association shall hold two offices at the same time. This includes serving as an officer in a campus club (as recognized by Inter-9 Club Council) or campus organization." 10 Mount SAC A.S. Officer Duties and Responsibilities Agreement 11 conditions for Public Servant Leader Role 5: "Disclose all conflict(s) of interest circumstances that pertain to this position." 12 13 This allegation has been reported (PCS report #20S-00060) and there is an ongoing 14 investigation per AP 5520. Although attending the Cal Poly Leadership Training in Fall of 2019, 15 where multiple times, AS Advisor Andi Sims has stated clearly that you may not serve as a member 16 of Associated Students and as an officer of a RSCO (recognized student club or organization), 17 Shailah still kept her position as an officer of PTK and as the Academic Senator of A.S. 18 Shailah had the intent of breaking such a law, as Amy Truong, Claudia Fierros, and Kian 19 Bidari have witnessed a conversation in the Associated Students office, where Shailah interacted 20 with a former member of our Association (please see signed declarations by Amy Truong, Claudia 21 Fierros, and Kian Bidari attached as exhibit 4). 22 Shailah, after multiple times of being reminded of our rules, has broken them, time and time 23 again, and has used semantic arguments to try and justify her wrong doings. She has no respect for 24 the real meaning of the rules of our association and has shown to do everything in her power to view 25 these rules not as moral codes but things to get around. 26 After reviewing this case, the Student Court made a Preliminary Opinion (Advisory Opinion) 27 which found that student officers may not serve both as an A.S. Officer and an RSCO Officer 28 _4_

1 concurrently. 2 VI. **FOURTH CAUSE OF ACTION** 3 HARASSMENT 4 5 Mount SAC Standards of Conduct; Section 20. "Harassment of students and/or College employees that creates an intimidating, hostile, 6 or offensive environment." 7 8 This allegation has been reported (PCS report #20S-00060) and there is an ongoing 9 investigation per AP 5520. Shailah has bullied and intimidated Sophia, saying, "Instead of handling 10 it maturely, you decided to be petty and childish, and you tried to essentially get all of us kicked out 11 because you were angry that you weren't allowed to make it seem like you had the candidates 12 endorsing you when in reality you have no support" (these messages will be attached as the first 13 exhibit). Here, Shailah is referring to the fact that Sophia reported to the A.S. Advisors the malicious 14 and slanderous acts Shailah had committed in the 2020 A.S. Elections. 15 16 VII. **FIFTTH CAUSE OF ACTION** 17 DISHONESTY 18 Mount SAC Standards of Conduct; Section 14. "Dishonesty; 19 forgery; alteration or misuse of College documents, records or 20 identification; or knowingly furnishing false information to the College." 21 22 This allegation has been reported (PCS report #20S-00060) and there is an ongoing 23 investigation per AP 5520. During the interview process of Shailah for the position of interim Vice-24 President of Associated Students, when questioned what she had done during her appointment as 25 Academic Senator, she said, "I am working with Aya on a STEM survey," and went on to explain 26 in great detail the purpose of the survey and how she had been working with Aya to complete it. 27 According to Aya, Shailah was immaterial, insignificant, and dishonest when she had said to all of 28

Mount SAC A.S. Student Life Center Office Culture Norms Section 4, Sub-section A: "Be professional."

As A.S. officers it is our duty to uphold the student body in every possible way. This includes harnessing student's sentiments through legislation and defending their ability to elect their own student leaders and at the very minimum to be professional and to respect colleagues. Shailah attacked the integrity of our elections and our association by forgoing these rules and morals (please see Officer Duties and Responsibilities agreement with Student Life Center Office Culture Norms attached as Exhibit 7).

The Student Court has stated that Shailah's claims are unfounded and that no violations were committed by Sophia or her campaign. Shailah formed a baseless and malicious complaint, with no substance, in an attempt to appeal the democratic system we have put in place.

Associated Student's goals and laws hammer in on the fact that students get to choose their own leaders. Through her bad-faith, Shailah has shown she believes leaders get to choose themselves, through manipulation of both our systems and our officers. It is the will of the students that drives A.S. forward, not self-interest.

REMEDIES SOUGHT

WHEREFORE, Plaintiff respectfully seeks for judgment against Defendant as follows:

- 1. This Senate to order a Motion for Impeachment of Defendant;
 - 2. Defendant be removed from their Mount SAC Associated Students officer position in the term of Spring 2020;
- Defendant be barred from running, applying, campaigning, and/or becoming a Mount SAC Associated Students Officer for one year from the date such a judgement and subsequent order be made;
- 4. Defendant be barred from running, applying, campaigning, and/or becoming a Mount SAC RSCO officer (as outlined in a RSCO's

Declaration of Aya Garawi

- 1. My name is Aya Garawi, I am above 18 years old, and I currently serve as the STEM Senator for Mt. SAC Associated Students.
- 2. I declare that back when Shailah ran for AS Vice President, during the election day she and Andy, the other Vice President candidate, were asked of things they've accomplished so far in their respected Senate positions. Shailah mentioned that she had been "working with Aya to create a STEM survey, adapting to STEM students' needs" and went on to talk about the reasoning behind the STEM survey 'we' were conducting. Now, unfortunately due to unavailabilities and time restrictions on our schedules, James Reed (the STEM center coordinator) and I were not able to go through with the survey, and it was never given to students. However, I was able to meet with him, think of ideas, and ultimately submit a final edited document of the survey. At the beginning of the Fall semester, Shailah had approached me after I mentioned in one of our senate meetings that I was working on a survey with James, asking me how she could be involved. I gladly gave her the opportunity to be a part of this with me. We had almost one full conversation (with other small talk, that didn't accomplish or establish much) where she let me know her ideas, said that we should include a professor, Beta Meyers, and I asked for her schedule in order to find a time we could work on the survey with the two respected faculty members, and that was pretty much the bulk of the conversation. Other included ideas of questions that we both contributed to. I had sent her multiple emails, forwarded her emails from James and I, texted her for her availability when a convenient time had come and sent her the document James had emailed me, so that we both could edit and or add to it. She had never edited the document, though I had reminded her in person and sent her emails. She didn't make much effort to find a time we could all meet and talk about the survey. Most of the communication for availability had been between James and I. It came to a point where I just thought she had lost interest and didn't want to be a part of it, so I didn't make any effort to contact her about it. Therefore, I was a bit shocked to hear her response on the day of the AS Vice President election. She had made it seem that she worked on this survey with me, when in reality, the majority of the physical work was something I had done. Ultimately trying to convince the AS advisors and AS leaders to think that she had been a major contributor to this project, using my efforts to benefit her reputation as Academic Senator and ultimately using this as a possible way to earn the AS Vice President position.





When someone attacks your character for personal gain, it can be a jarring experience. It can be equally daunting trying to explain the sequence of events that led to it because they seem to come out of nowhere. Nevertheless, I will attempt to address the ways in which Sophia Ruiz intentionally degraded my character. Put simply, Sophia engaged in the following intentional and malicious conduct, with the intent of assassinating my reputation in order to steal votes in a close election.: Specifically, Sophia:

- Attempted to have my advertising material, as well as that of almost every other candidate, disqualified from the election due to false copyright claims
- Sent thinly veiled threatening text messages wrongfully accusing me of engaging in unethical conduct
- Spread defamatory rumors and falsehoods about me in order to ruin my reputation
- Distributed a text message conversation, in which she maliciously edited the threads to
 mislead and manipulate my colleagues, the students at large, and anyone who ends up
 reading the falsified text conversation (it was shared on the internet and it is now
 impossible to determine how widely disseminated it was) all so that she could discredit
 my character and win the election

In isolation, any of these attacks might be ignored as gamesmanship that, while evidencing the worst part of politics, could be excused, but taken together they demonstrate a pattern of underhanded, abusive behavior that can only be described as bullying and harassment. As a result, her conduct not only violates the Mt. SAC Student Code of Conduct and the Associated Students Constitution, it makes a mockery of our commitment as leaders of the Student Body to act ethically during the election process. Based on her transgressions, the only remedy that seems plausible is to disqualify Sophia Ruiz retroactively from the election, but I am open to other solutions that are equitable given the gravity of her actions.

Throughout the Associated Students election my opponent, Sophia Ruiz, displayed a pattern of abusive, manipulative behavior that she used to turn my friends and colleagues against me in order to win the election for Student Trustee. The behavior began with Sophia reaching out to me shortly after the filing for the positions had closed.

Sophia began by reaching out with a text accusing me of prior unethical conduct. In fact, she went so far as to state that she hoped I wouldn't again. When I assured her that I would continue not to break any rules, she indicated that she meant something deeper by her comments and again implied that I was engaging in unethical behavior regarding the campaign. (Exhibit A)

At the time, I did not reply to these comments because they left me confused as to her meaning. It was not until later that I realized she was laying the seeds so that she could tell others that I was unethical. In fact, given her later conduct, this may have been her first attempt to obtain texts from me for later "editing", but at the time I gave her the benefit of the doubt.

Following this initial conversation, Sophia's abusive behavior escalated beyond the point where anyone could mistake it for anything other than a blatant attempt to win at all costs. She began using artwork from other candidates with the clear intent of making the reader believe that these candidates were supporting her campaign. Not only were these candidates supporting me instead of her, but she also used the pictures without obtaining the candidates' or the artist's consent.

When the artist discovered the misuse of her work, she messaged Sophia asking her to take these graphics down due to her using artwork that wasn't her own. Sophia responded by sending a message to our advisor Giovanni Rodriguez, which resulted in every candidate, other than Sophia and Maricela, almost losing their ballot pictures and statements, if not days of campaigning due to election violations. But what cannot be ignored is that, if not for our ability to obtain a letter of consent to immediately counter her allegations, this would have been the result. (Exhibit B) (Exhibit C)

This underhanded tactic to disqualify the campaigns of those who did not support her was the second example of Sophia's pervasively abusive behavior and I directly addressed the situation with her. I angrily explained that it was not my fault that she did not have the support of others running, and that it was not right that she tried to disqualify candidates simply because she was not allowed to pretend as though they supported her when they did not. To this she apologized, but given her behavior after this point, I now realize this is where the smear campaign against myself and the candidates who supported me began (Exhibit D).

From the point where she was finally able to obtain the types of messages she could "work with" she started "editing" my comments to eliminate the context and remove those parts that described why I was upset, or that placed her in a bad light, all in order to intentionally discredit me to my colleagues. To them, she spun the situation and only included the newly doctored comments where it seemed as though I was attacking her by reaching out to her out of sheer spite to tell her that nobody supported her, despite the fact I clearly indicated that I was simply talking about the candidates for other offices in the full text message thread. In other words, with manipulative intent, she took my statements out of context and turned them into an attack on her. But the best part of her scheme was the timing, because it was all geared to affect the election before I could defend myself.

Our conversation occurred on the Friday preceding Election Week, and I moved forward with the campaign giving all of these grievances little thought. It was not until almost a week later on Thursday, the last day of voting, that I found out from a third party that Sophia had been secretly sending around edited versions of our conversation all week. In her attempt to cast doubt on my character and turn all of our colleagues against me, she had inadvertently approached someone who informed me of what was going on. This bears repeating, she did not approach me or confront me with accusations of wrongdoing, as someone who felt genuinely aggrieved, instead I had to find out by having the edited text messages sent to me by a mutual friend, who wanted to know the context of the comments I had made.

Needless to say, but still not clear on the extent of her deception, I apologized for my comments, giving her the benefit of the doubt, yet again, and wanting to bury the hatchet with someone I considered a colleague. It was at this point that she really put her plan into full throttle. She refused to put things behind us and began to openly twist the situation into one where she was the victim who was bullied despite all of her manipulative behavior to discredit me (Exhibit E).

I later saw in one of our group chats that Sophia had been attacking myself and Hugo, calling us hypocrites and insinuating that we lacked moral character. This harassment in our chat, along with the texts she was sending around to our colleagues and the public posting of these edited texts on her Facebook, constitute an attempt to bully and assassinate my character in a way I have never experienced. Below I have included both the original text and the edited text she posted on her Facebook with the clear intent of garnering sympathy through her false narrative (Exhibit F).

The amount of effort she put into systematically dispensing this false narrative in order to stop people from voting for me made me feel isolated and unwelcome in Associated Students. I received further confirmation after the election that she had reached out to other colleagues during the election with the same false narrative, in order to make me out to be a bad person. She clearly did this with the intent of swinging the election, waiting almost a full week before coming after me publically with her lies so that there could be no repercussions for her actions, given voting at that point was all but done. These actions clearly violate the Student Code of Conduct, the Associated Students Constitution, and most likely the elections rules as well.

Unless we are all willing to allow Sophia Ruiz to profit from her disgraceful conduct, I believe the only recourse at this point is to disqualify her from the election in order to maintain the integrity of our process and institution. I am open to other equitable solutions, however I see no other repercussions that can achieve an open and fair election, given the voting has already taken place and her statements have already permeated amongst my colleagues and the voters. Allowing her to serve after bullying and lying her way into the position sets a dangerous precedent that would tell future campaigns that slandering someone, falsely copyright striking them, and bullying are effective ways of becoming Associated Students leadership. If there is any doubt in your mind that what she did cannot be tolerated, ask yourself this: What is the difference between what she did and any other false allegation that uses doctored conversations to lie to voters? There has to be a line and she has crossed it.


